All Entries Must Be Picked Up

- **Pre-entry is required for all shows. Entry forms are located on the Registration / Entry Forms tab. Mail-in or online registration will be available on the website. (hamblencountyfair.org)**
- **Health papers are required for all animal entries. Registration papers and lease papers (where appropriate) are required for all registered animals.**
- **Out of control animals will be disqualified.**

Fair Entry Rules and Regulations

1. Open Show Competitions (Departments A1, B1, C1 and D1 ONLY) are open to anyone who can exhibit their animal WITHOUT assistance. Market Steers (Dept. A2), Dairy Steers (Dept. B2), Market Goats (Dept. C2), Market Lambs (Dept. D2) and Commercial Ewes (Dept. D3) are NOT Open Shows. These and all other competitions are open to Junior contestants ONLY.
2. Junior Show Competitions (all Departments except A1, B1, C1 and D1) are subject to the following rules on age or grade:
 - a. All youth exhibitors must be members of 4-H or FFA by January 1, 2026.
 - b. Competition is limited to either 4-H members who were enrolled in the fourth grade or later and FFA members who were enrolled in agriculture education courses on January 1 of current calendar year and who have not reached the end of the calendar year of their high school graduation or the end of the calendar year of their 20th birthday, whichever comes first.
 - c. When grade divisions are used, the exhibitor should enter the grade he or she was enrolled in as of January 1 of the current year.
3. Only 2024-2025 projects may be exhibited and only work done since the fair last year is eligible.
4. Exhibitors may enter only one entry per lot, except livestock which has a maximum of two (2) entries per lot.
5. Items except livestock must be made or grown by exhibitor.
6. All animals must be cared for and fed by exhibitor. Feed will be furnished by the exhibitor.
7. All entries must be in place before assigned judging.
8. All livestock entries must be in place as listed in the catalog for each individual class.
9. At the conclusion of the fair, the exhibitor must claim and take charge of exhibits. Claim checks must be presented before an exhibit can be removed.
10. The right is reserved to withhold any award where it appears fraud or deception has been made. Judges' discretion will be used in opening canned items if fraud or deception is expected.
11. The fair management reserves the right to interpret the rules and regulations and to settle all questions that may arise.
12. No articles made from kits will be accepted as eligible entries unless specified in specific category.

13. All protests must be in writing to the president accompanied by an affidavit setting forth the grounds for protesting.
14. Protests against the exhibition or any entry must be filed at least two hours before the lot is judged and will be considered and determined before the judging of said lot.
15. Protests against an award must be filed within 23 hours after the show on the day the award is made and will be determined at the first meeting of the rules committee.
16. These rules apply to all departments, except where noted and should be read by every exhibitor, who should govern himself accordingly. The fair reserves itself the sole and absolute right to construe its own rules and regulations and to determine arbitrarily all matters and differences in regard thereto, from which no appeal lies.
17. In the event of conflict of general and special rules, the latter will govern.
18. All property of every character, whether entered for exhibition, display or sale, or any other purpose will be taken into the grounds and buildings and kept entirely at risk of the owner, who assumes all responsibility for any loss, damage, theft or accident that may occur. Neither the fair nor its officers or agents will be responsible for any such loss, damage or theft, and it is directly understood that exhibitors, concessionaires and all other persons, firms or corporation having property on the grounds and desiring protection from such loss or damage must make their own arrangements therefore.
19. The solicitation of funds or the distribution of handbills, political literature, religious pamphlets or any type of promotional material is prohibited on fair property unless it is given out from rented space. No posting of advertising material will be allowed on the buildings, barns or fences unless approved in writing by the management.
20. No alcoholic beverages are allowed on the grounds.
21. No smoking in barns or exhibit buildings.
22. Animals are not permitted on the grounds unless they are part of an authorized show or exhibit. Guide dogs for the disabled are the exception.

Livestock Specific Rules

Registration is REQUIRED. You must register with complete information including email on the entry form and the form must be received in the Hamblen County Extension office no later than June 20, 2026. They can be mailed, emailed, faxed to the office or completed online at hamblencountyfair.org. If emailed or faxed the entry fees must be received within 10 days of the email/fax. You will receive an email confirmation once your registration and/or payment is received.

AFTER JUNE 20 NO ENTRIES WILL BE ACCEPTED.

1. Be sure to use separate registration forms for each species and breed of animal and also for each exhibitor. Complete information is required.
 2. No more than two (2) entries allowed per lot.
 3. There will be NO REGISTRATION the day of the show.
 4. Departments A1, B1, C1, and D1 ONLY are considered Open Shows and will be open to anyone.
 5. All other Departments (except A1, B1, C1 and D1) will be considered Junior Shows and you must be a current 4-H and / or FFA member (4th -12th grade on January 1, 2026) in order to compete in the competitions. There are some exceptions for "Little" classes in beef cattle, dairy cattle, goat and sheep.
 6. Animals may only be exhibited in either breed (registered) or as market or commercial classes. They cannot be entered into multiple categories.
 7. There will be spaces allocated in the barn for you to tie/stall your animals. Please plan to use only the space allocated for you and to work with others to make the best accommodations for everyone. Sheep and goat exhibitors may bring your own panels to use within the warm-up arena for additional separation if preferred but you may NOT show from your trailer.
 8. Please ensure that you keep aisle ways clear and open for the movement of animals.

9. Generators may be brought and used but must be kept outside of the barns.
10. Shavings may be available for sale from the Expo Center. Any other bedding may be brought in by the exhibitor.
11. There will be a Supreme Champion selected for each species. Eligible animals will come from the respective Grand Champion classes.

Hamblen County Great Smoky Mountains Fair Animal Welfare Statement

The Hamblen County Great Smoky Mountains Fair is committed to the highest standards of animal welfare. The humane treatment of all livestock exhibited at the fair, including Dairy Cattle, Beef Cattle, Sheep, Goats, and Chickens, is a top priority. Exhibitors, handlers, and participants must adhere to the following guidelines to ensure the well-being of all animals.

1. Prohibited Conduct:
 - a. Any form of animal abuse, neglect, or mistreatment will not be tolerated.
 - b. Excessive hitting, striking, or handling animals in an aggressive manner is strictly prohibited.
 - c. The use of forceful techniques, including but not limited to excessive pulling, lifting, or improper use of equipment, is not permitted.
 - d. Excessive striking of animals in the show ring to "brace" the animal (i.e. Market Type Lambs).
 - e. Animals should not be tied up for extended amounts of time at the wash bay.
 - f. Animals are required to be brought inside of the Expo Center; keeping animals on the trailer is not allowed.
2. Enforcement:
 - a. The species chair will oversee compliance with this policy and consult the fair board as needed.
 - b. Any individual found violating this policy will be subject to immediate disciplinary action.
 - c. Violators will be excused from the premises and will forfeit all premiums, prizes, or awards.
 - d. Further penalties, including potential bans from future participation, may be imposed at the discretion of the Fair Board.
3. Reporting Violations:
 - a. Any concerns regarding the treatment of animals should be reported to Fair Board officials or designated show superintendents immediately.
 - b. Reports will be taken seriously, and appropriate action will be taken following a fair and thorough investigation.

1. All birds must meet health regulations according to State requirements. The chairman reserves the right to refuse any entry.
2. Only one entry per gender per lot. Entries consist of single birds in large breeds and Bantam breeds.

ANIMALS FROM OUT-OF-STATE

Cattle from out-of-state must be accompanied by an official Certificate of Veterinary Inspection within 30 days of issue. Individual permanent, official identification is also required. Lactating dairy cattle from out-of-state must undergo pre-movement H5N1 testing, per USDA guidelines. The certificate must include the date of sample submission, negative test results, and the animal's official ID. Contact (615) 837-5120 for testing guidance.

REMOVAL OF ANIMALS

Cattle that are not in good health must be removed immediately from any fair, show, or exhibition.

Signs of disease in cattle may include (but are not limited to):

- Fever
- Lethargy
- Coughing
- Sneezing
- Patchy Hair Loss
- Warts
- Foot Rot
- Nasal and/or Ocular discharge
- Red/Inflamed Crusting Skin Lesions

Fair, Show, & Exhibition Rules for Sheep and Goats



IDENTIFICATION

All sheep (except wethers under 18 months produced for slaughter) and registered breeding goats that have been commingled with sheep, goats for exhibition, and dairy goats that move within the state, including for change of ownership, shows, fairs, expositions, or slaughter must be permanently, individually identified by a method approved in Title 9, Code of Federal Regulations, Part 79.1 through 79.4.

CERTIFICATION

A Certificate of Veterinary Inspection for Tennessee livestock traveling in-state is valid for 90 days from date of issue.

VACCINATIONS

UT Extension recommends the following vaccines for sheep and goats traveling to fairs, shows, and exhibitions. Livestock owners are encouraged to consult with their veterinarian to determine the vaccine schedule and needs for individual animals.*

Campylobacter for breeding stock
Chlamydia for breeding stock

REMOVAL OF ANIMALS

Sheep and goats that are not in good health must be removed immediately from any fair, show, or exhibition.

Signs of disease in sheep and goats may include (but are not limited to):

Summary of Regulations and Health Requirements for Livestock at Tennessee Fairs, Shows, and Exhibitions

1. It is expected that all exhibitors bring only healthy animals to fairs, shows, and exhibitions. Although state and federal animal health officials will be performing as many inspections as possible, fair officials are responsible for ensuring that all animals are in overall good health and have appropriate required health and/or identification documentation for the species. Animals showing clinical signs of contagious disease must be sent home immediately. Violations must be reported to the state veterinarian or her agent.

2. A Certificate of Veterinary Inspection (CVI) is to accompany every livestock animal to a fair, show, or exhibition with the exception of equine and poultry from Tennessee. In-state Tennessee equine 6 months of age or older must have proof of a negative Equine Infectious Anemia test within the preceding 12 months. Poultry assembled at fairs, shows, or exhibitions must be accompanied by proof of a negative test for Pullorum-Typhoid within 90 days, or be tested on-site prior to exhibition following strict biosecurity procedures, or originate directly from a flock certified Pullorum-Typhoid Clean under the National Poultry Improvement Plan. As part of increased awareness and surveillance for avian influenza and other poultry diseases, the physical appearance of all birds should be assessed at the time testing is conducted.

3. A CVI issued in satisfaction of Tennessee animal health regulations is good for 90 days for Tennessee livestock only.

4. A CVI demonstrates that the animal showed no signs of contagious disease at the time of veterinary exam and CVI issuance. An animal developing signs of disease after inspection but during the period the CVI is valid is still subject to rules refusing entry of animals with contagious diseases to fairs, shows, and exhibitions.

5. Please note that exhibition requirements for out-of-state livestock are the same as regular import requirements. Learn more at www.tn.gov/agriculture.

6. Warts, ringworm, scabies, contagious ecthyma (soremouth), foot rot, cutaneous fungal and bacterial infections (i.e. club lamb disease, caseous lymphadenitis, pink eye/conjunctivitis) are considered contagious and infectious diseases and are NOT permissible.

7. All out-of-state poultry must originate directly from a Pullorum-Typhoid Clean Flock and a H5/H7 Avian Influenza Clean Flock, or be accompanied by evidence of a negative Pullorum-Typhoid test within 90 days and a negative official avian influenza test within 21 days.

Also, please note that if highly pathogenic avian influenza is detected in Tennessee or a neighboring state, commingling of poultry at fairs, shows, and exhibitions may be suspended.

Biosecurity for Fairs, Shows, and Exhibitions

The National Assembly of State Animal Health Officials and the National Association of State Public Health Veterinarians make the following recommendations for managers of fairs, shows, and exhibitions to protect attendees from disease:

- Provide easy access to hand washing stations.
- Post signs that advise:
 - No eating or drinking in the animal stabling or exhibition areas.
 - No pacifiers, sipping cups, or strollers in the animal stabling or exhibition areas.
 - Wash hands frequently.
- Discourage sleeping in the animal exhibition areas.
- If influenza-like illness is associated with the fair, show, or ex-

hibition, animal health and public health officials should be notified immediately.

- People who have influenza-like illness should leave the event immediately and seek medical care. They should advise their health care provider about their fair, show, or exhibition attendance.
- People at high risk for developing severe complications from influenza should limit their exposure to swine.

Also, be aware of the potential exposure of attendees to salmonella and E. coli from animals present on the grounds.

Fair, Show, & Exhibition Rules for Poultry



CERTIFICATION

Tennessee poultry must be from a flock certified with the National Poultry Improvement Plan or must have evidence of a negative Pullorum-Typhoid test within 90 days and a negative Avian Influenza test within 21 days. Some events may have on-site testing.

VACCINATIONS

UT Extension recommends the following vaccines for poultry traveling to fairs, shows, and exhibitions. Livestock owners are encouraged to consult with their veterinarian to determine the vaccine schedule and needs for individual animals.*

Poultry

Marek's disease
Coccidiosis**
Fowl Pox

* Vaccines are not required but strongly recommended.

** Birds vaccinated for coccidiosis should not be fed medicated feed with a coccidiostat (amprolium)

ANIMALS FROM OUT-OF-STATE

Poultry from out-of-state must be from a flock certified with the National Poultry Improvement Plan or be accompanied by a Certificate of Veterinary Inspection and evidence of a negative Pullorum-Typhoid test within 90 days and a negative Avian Influenza test within 21 days.

REMOVAL OF ANIMALS

Poultry that are not in good health must be removed immediately from any fair, show, or exhibition.

Signs of disease in poultry may include (but are not limited to):

- Lethargy, drooping wings
- Swelling of the head, eyes, comb, wattles, or hocks
- Discoloration of the comb, wattles, or legs
- Nasal or eye discharge
- Coughing, wheezing, or sneezing
- Diarrhea
- Hunched appearance while standing
- Dirty wings

Even with vaccinations, good biosecurity must not be overlooked. Birds returning home from fairs, shows, or exhibitions should be isolated as far as possible (at least 100 feet) from the remainder of the flock for 30 days.
